## TOURNAMENT INFORMATION

### PLAYER ELIGIBILITY:

- Players must be amateurs (as defined by USA Racquetball) and Illinois residents. USAR membership required and payable online before entering.
- The ISRA reserves the right to reclassify or deny any entrant in the interest of fair competition. Skill division eligibility is determined by rank of the highest classified partner.

### CHECK-IN:

Players must validate their USA Racquetball/ISRA membership at the check-in desk **before** their first match. **Please bring proof of membership.**

### MATCH PLAY:

- Official Ball: Penn Pro HD (Purple)
- Forfeit Rule: Ten (10) minutes past **scheduled** match time.
- Scoring: Current USAR rules apply.
- AA Division will form from first round Open losers. *This is a new division, not consolation.*

### CONSOLATION:

- First round losers (except Open) register immediately after first match.
- Scoring: Best of three games to 11 (Finals will be regular match scoring). Referees provided for finals only.

### REFEREES: Referees will be paid \$5 per match.

All match losers have an obligation to referee the next assigned match. Round Robin divisions will not be refereed.

### AWARDS:

Awards will be given to First and Second place finishers in all divisions.

### TOURNAMENT SOUVENIR:

Each player will receive a tournament jacket.

### ENTRY FEES:

- **Each player must enter individually.**
- First Event = \$40 per player
- Second Event = \$20 per player
- Junior first event = \$30 per player
