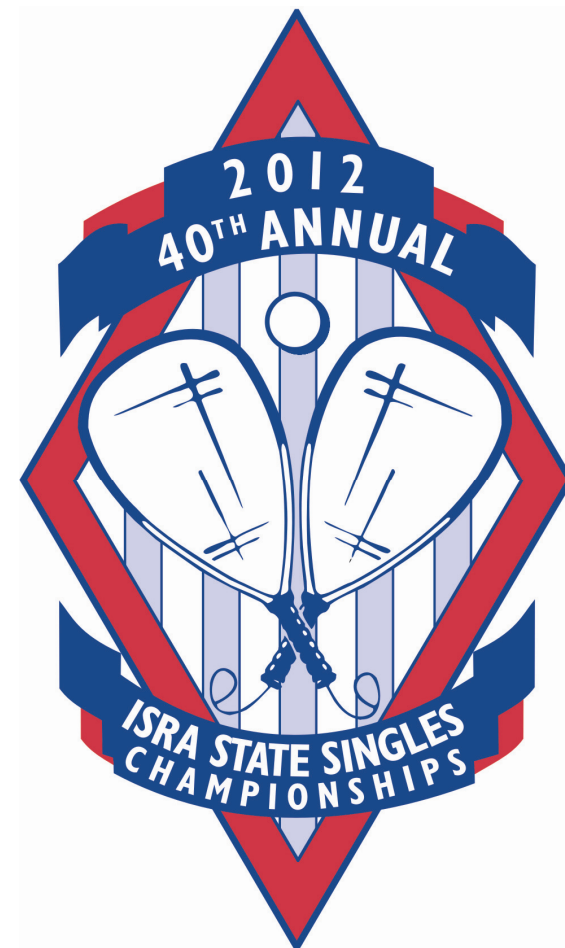

### PLAYER ELIGIBILITY:

- Players must be amateurs (as defined by USA Racquetball) and Illinois residents.
- USA Racquetball membership required of all entrants (annual dues \$50 adult, \$25 junior, or event dues \$10).
- The ISRA reserves the right to reclassify or deny any entrant in the interest of fair competition.

### MATCH PLAY:

- Official Ball: Pro Penn HD (purple)
- Scoring: Current USA Racquetball rules apply.
- Approved eyeguards mandatory.
- Referees will be paid \$5 per match. All match losers have an obligation to referee the next assigned match. Round Robin divisions will not be refereed.
- AA Divisions will automatically form from first round losers in Men's and Women's Open.
- Consolation will be offered on a sign-up basis pending court availability.
- If consolation is offered, it will be players' responsibility to check posted match times.

### AWARDS:

- Medals awarded to 1st and 2nd place (plus 1st place consolation, if offered) in all divisions.
