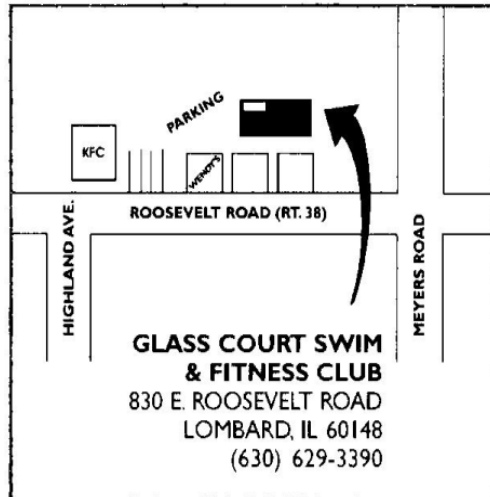

Entry deadline/payment:

Entry deadline for guaranteed registration is 8pm Sharp Monday, March 12, 2012. **Entries accepted after the deadline will pay \$10.**

New Changes:

1. **Please note all entries must be registered online. To enter go to www.r2sports.com** . Any entries called in or dropped off at Glass Court must be completely filled out and legible. All entries must be paid in full.
2. In addition, phone entries will be charged a **\$5** handling fee. Entries also available at www.illinoisracquetball.com. Late entries will be accepted at the tournament director's sole discretion. Please get your entries in early as draws will be limited.
3. In order to help keep the entry costs from increasing, and the hospitality at the same level you have come to expect, we have adopted a new rule used by many other associations. The rule is that **the winner of a match is required to referee the next available match** in order to move to the next round.

Eligibility:

A current USAR membership is required of all participants. Non-members will be required to purchase a membership for \$50/year or \$10 (one tournament only). Only amateurs may participate.

Starting Times:

Times may be obtained via Internet at www.r2sports.com or call Glass Court (630) 629-3390 after 7pm, Wednesday March 14th.

Matches may begin as early as Thursday night, 6:00 pm.

Matches will resume Friday at 4:00 pm. Consideration will be given to players from outside the Chicagoland area. Please note on the entry.

Consolation:

We regrettably cannot offer consolation, due to the large draw. All players who lose their first round match will receive a \$10 certificate towards our Summerfest Tournament, July 2012.

Referee Information: Winners must referee the next scheduled match, or you will be forfeited.

General Information:

- IRT rules and scoring apply to all Pro/Open matches.
- USRA rules apply; matches will be 2 games to 15 points, 11 point tiebreaker, if necessary.
- Directors reserve the right to reclassify or deny any entrant in the interest of fair competition.
- Licensed, approved eye guards are mandatory.
- Towels available with a \$2 refundable deposit. Please bring your own lock.
- Six entries are necessary for each division to avoid cancellation or combination.
- First round match non-winners (except top seeds) in the Pro/Open Singles, will automatically move to AA division. No AA division for Doubles.
- No children (under 14) will be allowed in the club without direct supervision.
- **Please note: Men's A-D singles and B-C doubles could start on Thursday night after 6pm.**

Prize Money Information:

- Cash prizes will be pro-rated with less than 16 entries in Open Singles Divisions and 12 entries in all other singles divisions.
- Cash prizes will be prorated with fewer than 12 teams in all doubles divisions.
- All finals matches must be played during the scheduled tournament weekend to receive prize money.
- Doubles prize money is per team.
- Novice divisions will receive gift certificates for 1st and 2nd place.
- Any divisions with less than 6 entries/teams will receive gift certificates (no cash awards) for 1st and 2nd. Divisions of 4 or fewer will receive gift certificates for 1st place only. A minimum of 6 players in AA divisions are required to hold prize money.
